



Reasons for rejection of claims of Financial Creditor:

- A. Part of claim submitted by Union Bank of India amounting to Rs. 29,81,170/- (Rupees Twenty Nine Lakhs Eighty One Thousand One Hundred and Seventy Only) have been rejected on the grounds of charging interest over and above the liquidation commencement date.
- B. Part of claim submitted by Andhra Bank amounting to Rs. 75,000/- (Rupees Seventy Five Thousand Only) have been rejected on the grounds of including legal expenses in the claim, without production of any sufficient proof of including such expenses in the claim.

Reasons for rejection/verification of claims of Operational Creditor:

- C. Part of claim submitted by Mayo Integrated Industries Ltd. amounting to Rs. 17,36,643/(Rupees Seventeen Lakhs Thirty Six Thousand Six Hundred and Fourty Three Only)
 have been rejected on the grounds of non-production of sufficient proof for charging
 interest amount in the claim.
- D. Claim submitted by Western Indian Metal Processors Limited is kept under verification owing to proper production of proofs substantiating the claim.
- E. Claim submitted by Sales Tax Department is kept under verification as the proofs substantiating the claim were provided latestly on 14/01/2020.
