Have you decided the date by when the Roll On-Roll Off (Ro-Ro) services between Mumbai and Alibaug will

The Ro-Ro services between Mumbai and Alibaug will start from the second week of March. We are waiting for time from the chief minister to inaugurate the project. The trial runs for the service will be completed between February 27 and March 4. Hopefully, in the second week of March, commuters can avail the services. It will not only save time for commuters heading to Goa and Konkan but will also decongest road traffic. We are hopeful that nearly 12 lakh commuters will use the Ro-Ro services annually

There were eight Ro-Ro services planned in (Mumbai Metropolitan Region) MMR and Mumbai. What is the current status of these

Work on constructing jetties for the Ro-Ro services are going on. By June, we will be able to complete the Nerul jetty, which will play an important role in providing water transport connectivity between Navi Mumbai and other regions, including Kalyan, Thane and Mumbai. Apart from this, construction of a jetty in Gorai is also going on at a good pace and will be ready by September this year. Work on six other jetties - Manori, Narangi, Bhayander, Borivali, Belapur and



Veldur – will be completed by March 2021.

There was a plan to connect Mumbai and other municipal corporations in MMR

through water transport. The plan to create water transport networks between MMR and Mumbai has been delayed by lack of funds. No one wants to invest in infrastructure required for water transport. The Thane Municipal Corporation (TMC) was supposed to prepare a masterplan with 33 routes but, as of now, there is only one route in that circuit, which will start from September this year. This route will connect Navi Mumbai-Kalyan-Mira Road.

Is funding the main problem why these projects are not

taking off? Yes, funds are the biggest issue. That is the main reason why plans to develop water transport has failed since 1978. The Public Private Partnership (PPP) model will not work in terms of creating infrastructure for water transport. Private players will come, operate the ferries but will not invest in creating jetties. For any public transport, infrastructure is the responsibility of the government. No private player will invest Rs 600-800 crore. As per our new plan, we will pro-

CHIEF MINISTER Uddhav Thackeray on Sunday said that the first list of the farm loan waiver scheme will be released on Monday and the loans of 20.000 farmers will be waived off. Thackeray further said that the lists will be released in phases and the exercise would be completed by May.

"The first list of farm loan waiver will be released tomorrow (Monday). The list will include farmers from two villages each in every district. It is to see whether the system that is being used for farm loan waiver is functioning properly. The next list will be released on February 28. We plan to complete the farm loan waiver scheme by May," said Thackeray while addressing the media at Sahyadri Guest House

on the eve of the Budget Session. Apart from Thackeray, Deputy Chief Minister Ajit Pawar, Home Minister Anil Deshmukh and Parliamentary Affair Minister Anil Parab with two junior ministers were present. Interestingly, senior Congress ministers were not present.

While the government has planned to bring 13 Bills in the Assembly session, it however does not mention about bringing a Bill to make Marathi language compulsory in schools of all boards in the state

Ajit Pawar said around 35 lakh farmers have claimed they are eligible for the farm loan waiver up to Rs 2 lakh. "But, the exact number of beneficiaries will be known after verifying their claims," he added.

Thackeray also said that the government will fight the cases against Maratha reservation with full might in the court. "I am sure the government will win the battle," he added.

Taking potshots at opposition BJP, Thackeray said that it should work as strong opposition and should make suggestions and issues of people. "The government is stable and started functioning well but the opposition is not able to digest the fact. That is why they are leveling baseless allegations," he added.

Deshmukh said he along with the five senior Home Department officials had gone to Andhra Pradesh to get information on the DISHA Act. "We are planning to bring a similar law in the state with some changes in it. We have set up a committee of five senior officials that will give the report by March 30. Then, it will be put before the cabinet and then will bring it in the next Assembly session," he said.

DIDN'T HAND OVER ELGAAR PARISHAD TO NIA. **SAYS UDDHAV**

Chief Minister Uddhav Thackeray clarified in Mumbai on the eve of the Budget Session that he didn't handover the Elgaar Parishad probe to the NIA. "I didn't hand over the case to the NIA but the Centre took it in its right. We have expressed our displeasure on it as they have shown mistrust on the state's investigative agency," he added.

While ruling out any coverup in the investigation by his government, Fadnavis said, "Neither the Bombay High Court nor the Supreme Court had any objection to the investigation by the then state police. However, it is evident that the NCP president is keen on revoking the matter with a definite agenda."

Shortly after the Bhima

Koregaon violence, Fadnavis recalled how the NCP president had convened a press conference and alleged the role of rightwing leaders Milind Ekbote and Sambhaji Bhide.

Accordingly, the then BIP-Sena government initiated a probe. Bhide was given a clean chit but action was taken against Ekbote. "By setting up an SIT to re-look into the Bhima Koregaon case, Pawar wants to hold Hindutvawadis responsible for the violence," Fadnavis said.

"Why is Pawar so keen on a ate probe into Elgaar Parishad? The Maoist link was not limited to Maharashtra. It was interlinked to various states which has to be probed by central agencies like the NIA. There are adequate documents to establish the role of Maoists," he said.

Elgaar Parishad was an evening event organised at Pune's Shaniwar Wada on December 31, 2017, a day before the 200th anniversary of the Battle of Bhima Koregaon, which every year attracts lakhs of pilgrims to a war memorial in the village of Koregaon Bhima, 25 km northwest of Pune. On this occasion, violence broke out in areas around Pune, resulting in the death of one person and iniuries to several others.



ON WAITING

CHIEF MINISTER Uddhav Thackeray is keen to avoid any controversy over the appointment of Shiv Sena MLA Ravindra Waikar and Sena MP Arvind Sawant to key positions in the Cabinet. We have heard that both the leaders have been asked not to formally accept their appointment letters till the government consults legal experts on whether their appointment will constitute Office of Profit. The Thackeray government had earlier issued appointment orders of Waikar as chief coordinating officer in the Chief Minister's Officer and of Sawant as the head of the state parliamentary coordination committee.

IN A SPOT OF BOTHER

HIGH-PROFILE BUREAUCRAT and Thane civic commissioner Sanjeev Jaiswal landed in a controversy this past week for allegedly making derogatory remarks against civic officials on a WhatsApp group. While the episode led to an uproar in the Thane municipality's general body meeting, it could also cast a shadow on Jaiswal's next assignment. Having completed five years in the Thane civic body, the 1996-batch IAS officer is due for a transfer. Chief Minister Uddhav Thackeray has been briefed about the controversy, sources said.

COMMANDER-IN-CHIEF

WHEN UDDHAV Thackeray flew to Delhi on his first visit after taking charge as the chief minister, Chief Secretary Ajoy Mehta accompanied him. Sources also said Mehta had played a key role in drafting the state's wish list, which was handed over to the Centre. Thackeray's recent bureaucratic transfer exercise also had Mehta's imprint on it. Just as Mehta's extended term ends in March, sources said he has continued to be Thackeray's commander-in-chief as far as state administrative affairs are

STEPPING IN

STEPPING IN to curb arbitrary recruitment to plum postings with Maharashtra Housing and Area Development Authority (MHADA), the state administration has barred the authority from recruiting officials on deputation without its concurrence. Orders issued by the state's housing department last week make it clear that all such recruitment will now have to be cleared by high-level committees appointed by the government. Chief Minister Uddhav Thackeray's office will sanction all appointments on deputation for Class I posts and Housing Minister Jitendra Awhad will approve Class II postings. Deputations to lucrative posts in the MHADA are much sought after, especially by officials from the all-powerful revenue department.

Pressure Tactic

THE BIG daddies are at it again. Sources said the builders' lobby has started pushing the demand for a further drop in premiums on additional floor space index. While Chief Minister Uddhav Thackeray has not yet given into the pressure, we have been told that the CMO has asked authorities in the urban development department to consider the demand. A top-notch builder, with past controversies to his name, has been frequenting Mantralaya a lot these days and has become a subject of debate in the corridors of power.

Police unearth human trafficking racket while probing 'terror' tip-off

EXPRESS NEWS SERVICE MUMBAI, FEBRUARY 23

THE CRIME Branch of Mumbai Police on Sunday claimed to have detected a human trafficking racket while investigating a potential terror threat. Police received a tip-off that seven persons were being sent to Pakistan via Dubai to undergo training at terror camps, but when they were detained it was revealed during the interrogation that they were being smuggled into the USA, police said. They added that so far,

no terror links have emerged. "Police received information through mail on February 20 that seven persons, including a Pakistan-based woman, were likely to go to Pakistan via Dubai from Mumbai," said Deputy Commissioner of Police

(Preventive) Datta Nalawade. Nalawade added that the sender of the mail, who claimed

to be Rameesh Makhan, stated that this group will arrive in Pakistan to undergo training at terror camps and then return to India. "However, the interrogation revealed that the group was not going to Pakistan but to the US via Canada," Nalawade said.

He said, "We also found that the person who tipped us off was not named Rameesh Makhan, but Rizwan Sayyed. He is a Pakistan-origin man living in the US. We learnt that the familv members of these seven were in the US and had paid between \$25,000 and \$30,000 to Sayyed for the trafficking operation.'

Sources said while, so far, there was no clarity on why Sayyed tipped off the police, they suspect it was to ensure that the seven persons were detained here so that he could escape

with the relatives' money. According to police, the seven are aged between 28 and 35. Police have made no arrests.
