गतीमान युगात नीतमान साहित्य हवे

कोणत्याही संस्कृतीसंपन्न समाजाची अभिरुची तिच्या अभिव्यक्तीत असते. अभिव्यक्ती स्वातंत्र्याची चर्चा होते विशेषतः साहित्य संमेलनाच्यावेळी ती हमखास होते. परंतु ज्या साहित्याची जी अभिरुची जपली जायला हवी किंवा त्यासाठी अभिव्यक्ती स्वातंत्र्याचा उपयोग व्हायला हवा. याविषयी मात्र कोणी बोलताना दिसत नाही. याचा अर्थ अभिरुचीकडे सोयिस्करपणे दुर्लक्ष करायचे किंवा त्याचे भान न ठेवता केवळ अभिरुची स्वातंत्र्याचा उद्घोष करायचा. हा एकांगी विचार ठरतो. नाशिकमध्ये तीन दिवस सुरु असलेल्या साहित्य संमेलनाचा नुकताच समारोप झाला. साहित्य संमेलनाचे अध्यक्ष जयंत नारळीकर यांच्या भाषणातून काही महत्त्वाचे मुद्दे समोर आले. ते स्वतः विज्ञानवादी असल्याने मराठीमध्ये विज्ञान साहित्याची प्रचंड उणिव असल्याबद्दल त्यांनी खंत व्यक्त केली. ते स्वाभाविकही आहे. परंतु आजच्या विज्ञान युगामध्ये अनेक शोध लागले आहेत. माणसाचे जीवन गतीमान झाले आहे. परंतु केवळ गतीमान जीवन समाजाची अभिरुची टिकवुन ठेवू शकेल. त्याला नीतीमान साहित्याचीच आवश्यकता असते विज्ञान साहित्य हे नीतीमान असेलच याची हमी देता येत नाही. पण कोणत्याही स्वरूपाचे साहित्य जर सामाजिक किंवा वाचकांची बांधिलकी पाळत असेल तर ते अभिरुचीसंपन्नच असले पाहिजे. यात काही शंका उरत नाही. आणि ही अभिरुची नीतमान साहित्यानेच वृध्दींगत होऊ शकते. हे वेगळे सांगण्याची गरजही उरत नाही. विज्ञानवादी असणं म्हणजे बुध्दीमान किंवा प्रगल्भतेचा फार मोठे वरदान आहे. असा उसनवारीचा आव आणण्याची गरज नाही. विज्ञान हे एकूण जीवनाला पूरक ठरणारे पाहिजे. आणि म्हणूनच भारतामध्ये प्राचीन काळापासून लागलेल्या अनेक नवनवीन शोधांचा आणि समाजजीवनाचा समन्वय साधण्याचा प्रयत्न केला गेला. आजदेखील विज्ञान आणि जीवनमान यांच्या संतुलनाची आवश्यकता आहे. परंतु जगातले आज पन्नास टक्क्यापेक्षा जास्त वैज्ञानिक हे विज्ञानाच्या सकारात्मक परिणामांबद्दल साशंक असल्याचे दिसते.

अभिरुचीसाठी अभिव्यक्ती हवी

डॉ नारळीकरांनी विज्ञानाचा आपल्या भाषणात विज्ञानाचा पुरस्कार करणे स्वाभाविक होते. परंतु रामायण महाभारत काळापासून ते अगदी कालिदास , भवभूती यांच्यापर्यंत प्राप्त झालेली साहित्य संपदा दुर्लक्षित करून चालणार नाही. विज्ञानात रुची असणे ही काळाची गरज असू शकेल. पण समाजजीवनाच्या चिरंतन सुखासाठी सभ्यता आणि संस्कृती अत्यंत आवश्यक ठरते. म्हणूनच डॉ. नारळीकरांनी मांडलेला विचार काळानुरूप विज्ञानसाहित्याचा आग्रह धरणारा होता. मात्र काळाचे भान ठेवून जीवनमानाला समृध्द करण्याकरीता अन्य साहित्याची अधिक गरजेचे आहे असे म्हटले तर ते चुकीचे ठरणार नाही. नारळीकर ज्या खगोल शास्त्राचे अभ्यासक मानले जातात त्या क्षेत्रात भारतीय संस्कृतीने काही योगदान दिलेले आहे. वराह मिहीरांपासून ते आर्यभट्टांपर्यंत अनेक ऋषींनी केलेल्या संशोधनाची दखल घेणे तितकेच क्रमप्राप्त ठरते.

प्रत्यक्ष प्रयोग करून सत्य पडताळण्याची विज्ञानाची क्षमता आणि जे सत्य आहे. त्याचा शोध घेण्यासाठी केलेल्या प्रयत्नांची उपयक्तता यातला फरकही समजन घ्यावा लागेल. आज प्रामुख्याने साहित्य, वाङमय, कला संस्कृती याचा ज्यावेळेला विचार करतो त्यावेळेला सर्व प्रकारच्या साहित्यातून समाजमन प्रगल्भ होईल. विचारांच्या कक्षा रुंदावतील. याच दृष्टीकोनातून साहित्याचा विचार व्हायला हवा. दुर्दैवाने तात्कालिक प्रश्नांचा विचार होत राहातो. आणि आधुनिकतेची झूल पांघरून काही मूलभूत गोष्टींकडे दुर्लक्ष होते. अगदी स्पष्ट सांगायचे तर ज्या आध्यात्मिक विचारांच्या पायावर भारतीय संस्कृती टिकून राहिली त्या आध्यात्म आणि विज्ञानाचा समन्वय साधला जाणे ही काळाची गरज ठरते. या समन्वयाची नीट मांडणी झाली तर मातृभाषा किंवा अमृताते पैजा जिंकायला लावणाऱ्या मराठीची समृध्दताही लक्षात येऊ शकेल. मराठीपेक्षा इंग्रजी भाषा अधिक प्रगल्भ आहे असे विधान करण्याची कोणावर वेळच येणार नाही. मराठी या मातुभाषेने नेहमीच अभिरुचीचा विचार केलेला आहे. भविष्यकाळामध्ये ज्या ज्यावेळी साहित्य वाङमयाविषयी विचार होत राहील त्यावेळेला सर्वांनीच अभिरुचीचा विचार केला पाहिजे. केवळ अभिव्यक्ती स्वातंत्र्याचा ढोल बडवून आपला स्वार्थ साधण्याचा प्रयत्न होऊ नये.

A decision to this effect was taken in a weekly meeting of the workers of the Hukumchand Mill. The Hukumchand Mill had been closed in the city on December 12, 1991, rendering all the mill workers jobless all of a sudden. Since the closure of the mill, the mill workers have been running from pillars to post and also moved courts to get their dues but to no avail. A few days back the workers

closed in the city on December 12, 1991, rendering all the mill workers jobless all of a sudden

had also observed a one-day mass fast in support of their demands.

Without any prior announcement and pre-intimation to the workers, the management of Hukumchand Mill had locked the mill on December 12, 1991. The labourers were neither given any compensation nor were they paid gratuity. Even the salary remained unpaid. For their rights, the workers have been fighting a legal battle in the courts for the past 30 years. Even after the High Court's verdict years back for the

Hukumchand Mill had been payment of Rs 229 crores to the mill workers, the amount is yet to be released.

This amount is to be arranged by selling the mill land but the land is not being sold. INTUC's senior official Harnam Singh Dhaliwal and the president of the Hukumchand Mill Mazdoor Karamchari Samiti, Narendra Shrivansh informed that every Sunday after the closure of the mill, the workers gather at the mill gate demanding their rights. This Sunday also the workers gathered at the mill gate and decided to observe black day on December 12 to mark 30 years of the mill's closure. The duo said that the mill workers have now decided to continue a sustained agitation through Gandhian ways to get their dues.
